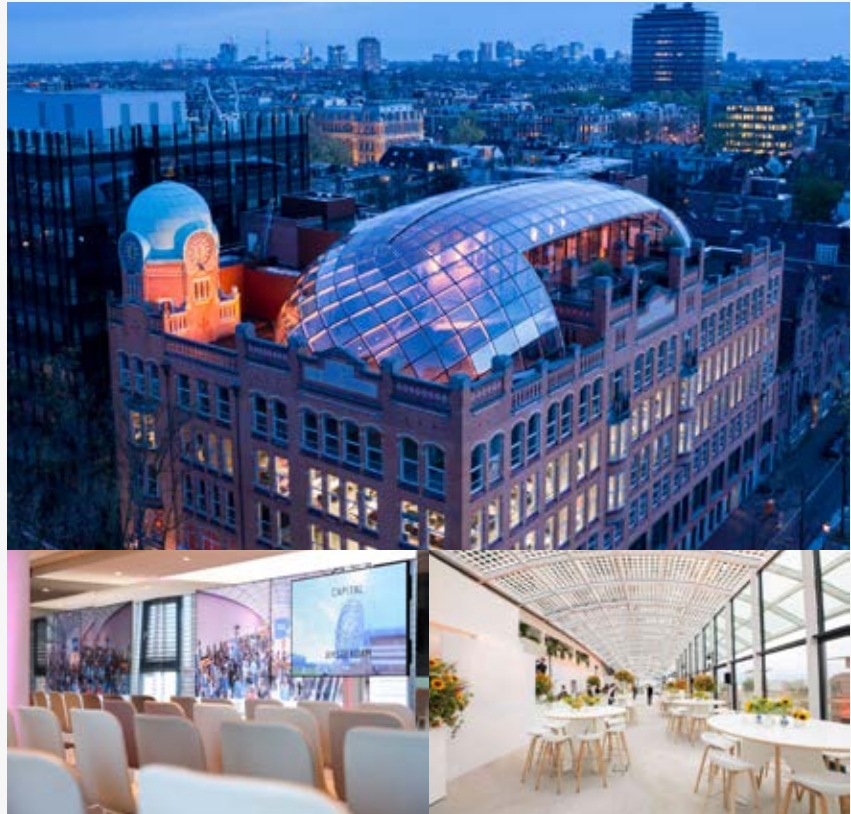

Speaker Keynote Address

Yas Banifatemi

GBS Disputes



Dr. Yas Banifatemi is a founding partner of Gaillard Banifatemi Disputes. Prior to that and until February 2021, she was Global co-Head of the International Arbitration group, alongside late Professor Emmanuel Gaillard, and the firm's Global Head of Public International Law.

Yas acts as counsel, arbitrator and expert. She is ranked in Band 1 of the Global Market Leaders by Chambers & Partners, and has been repeatedly praised in all leading professional directories. She is a member of the SIAC Court of Arbitration, a former Vice-President of the ICC International Court of Arbitration and a former member of the LCIA Court. She is listed on the ICSID panel of arbitrators, appointed by the Chairman of ICSID's Administrative Council.

She is the President of the International Arbitration Institute (IAI), succeeding the late Professor Gaillard in that capacity.

Yas teaches at Harvard Law School, Yale Law School and Panthéon-Sorbonne University. In the Summer 2019, she gave a course at The Hague Academy of International Law on the powers of the arbitrator. She co-founded and was the first Secretary-General of the Arbitration Academy. She researches in the areas of public international law and international arbitration, and has authored numerous publications in, and regularly speaks about, both these fields.

Matthias specialises in international arbitration and litigation. Matthias is a seasoned advocate and has first-chaired more than 50 merits hearings before international tribunals. He also sits as an international arbitrator, most recently in PCA-administered and ad hoc arbitrations.

His current and recent work includes: successfully representing the former majority shareholders of Yukos against the Russian Federation in setting aside proceedings before the Dutch courts in respect of arbitral awards worth more than USD 50 billion, representing a European energy company in several parallel UNCITRAL arbitrations in Zurich against another European energy company, with an aggregate amount in dispute of over EUR 10 billion, representing a European engineering company in an ICC arbitration in Geneva against a global confectionary producer, and successfully defending a European energy company in an UNCITRAL arbitration in Zurich against an application for an interim injunction by another European energy company seeking short-term deliveries of gas valued at EUR 1 billion, obtaining an award in favour of a global food delivery company in an ICC arbitration in Amsterdam, specifically enforcing a relationship agreement with another global food delivery company and safeguarding a multi-billion M&A transaction, obtaining an award in favour of a global special chemicals company in an ICC arbitration in Barcelona, specifically enforcing a joint venture agreement that the other side had sought to terminate, obtaining an award in favour of two European software companies in an NAI arbitration in Amsterdam, ordering the completion of an M&A transaction that the other side had sought to rescind, and obtaining an award in favour of a Chinese car manufacturer in an ICC arbitration in Paris, dismissing the other side's claims of over EUR 200 million in full and ordering the other side to bear all costs. Prior joining De Brauw, Matthias was Legal Counsel at the PCA. He served as the PCA's Representative in Mauritius and established the PCA's first diplomatic mission abroad.

In addition to his disputes work, David counsels clients on how to structure their cross-border investments in order to be well-positioned in case of future disputes with foreign governments, and he has advised multiple clients in connection with their exits from Russia following the Kremlin's full-scale invasion of Ukraine in February 2022.

David's arbitration practice focuses both on investor-state and on commercial disputes, often arising in Russia and Eastern Europe and in the energy sector. He has handled administered proceedings under the ICC, SCC, LCIA, ICDR, and AAA Rules, as well as ad hoc proceedings under the UNCITRAL Rules. On the commercial side of his arbitration practice, David has particular expertise in disputes arising under the Uniform Commercial Code. In U.S. litigation, his practice focuses on international law issues, including litigation in support of arbitration and applications for discovery under 28 U.S.C. § 1782.
