

Hamid Gharavi

She has also worked as an Associate Legal Officer at the International Court of Justice in The Hague, and as part of the arbitration practice of a major international law firm in Paris.

Irina is the author of numerous articles on international law and dispute settlement, as well as of a book on international law published by Oxford University Press in 2018.

Irina has received various awards, including the Clifford Chance Prize for Best Performance in the MJur Programme and Winter Williams Prize in International Economic Law at Oxford, as well as awards from the Royal Netherlands Society of International Law, the Rhodes Academy of Oceans Law and Policy, and various other organisations.

The European Union recently appointed Irina to the roster of arbitrators - alongside five other individuals - for the settlement of future disputes between the EU and the UK under the EU-UK Trade and Cooperation Agreement (TCA). Irina was also appointed to the pool of arbitrators and trade and sustainable development experts under the EU's trade agreements with third countries.

She is also a member of the Justice Rapid Response Roster of Experts, that may be deployed to assist in the investigation, analysis and reporting of human rights, humanitarian law and international criminal law violations.

Merryl has previously worked in two leading international law firms, at the International Court of Justice and for four human rights and transitional justice NGOs in Rwanda, Nepal, Colombia and New York. She has an active pro bono practice, advising and acting as counsel on complaints to various courts and human rights bodies, working on peace and transitional justice processes, advising on environmental obligations and dispute resolution options and as an expert on reparation efforts. Merryl speaks French and Spanish and is qualified in England & Wales and New York.

Robin Oldenstam is the head of Mannheimer Swartling's International Arbitration Practice and Chair of the SCC Arbitration Institute. Camilla is the Secretary General - Director General at the Netherlands Arbitration Institute. In that capacity she heads the staff and leads the direction for the institute. In 2023, the aggregate financial amount in dispute at the NAI amounted to approx. EUR 4 billion. The Netherlands Arbitration Institute was nominated twice during the Global Arbitration Review Awards ceremony in Paris in 2022.

Prior to becoming Secretary General at the Netherlands Arbitration Institute, Camilla was working as a Legal Counsel at the Permanent Court of Arbitration in the Peace Palace in the Hague. She was involved in setting up a specialist arbitration institute called P.R.I.M.E. Finance, which focuses son disputes involving complex financial instruments. Camilla has also been involved in drafting specialised arbitration rules for two other industries, the art sector (Court of Arbitration for Art) and the aviation sector (Hague Court of Arbitration for Aviation).

Prior to going institutional, Camilla was working as an atorney-in-law in private practice, both in the Netherlands as well as in New York. Camilla frequently lectures, presents and publishes on topics of international arbitration. She sits as Vice President at the International Federation for Commercial Arbitration Institutes (IFCAI), she is an Advisory Board member at the DAA, a Board Member at the Court of Arbitration for Art (CAfA) and a Board Member at the Hague Court of Arbitration for Aviation. Camilla is a CEDR accredited mediator.

Marieke is a counsel at Allen Overy Shearman Sterling in Amsterdam. 
