Speaker Keynote

Margriet Sitskoorn

Tilburg University



Prof. dr. Margriet Sitskoorn is a Full Professor of Clinical Neuropsychology at Tilburg University in the Netherlands. She is head of the Cognitive Neuropsychology department and director of the Zero Poverty Lab. Her research focuses on how behavior and environment aDect the brain, and how we can use this knowledge to prevent diseases and enhance functioning. Sitskoorn is an acclaimed public speaker and consultant. She is the author of several bestsellers, and her work has been translated into various languages.



Niek Strohmaier

Leiden University / RESOR



Niek Strohmaier is an attorney with RESOR, an Amsterdam-based law firm specializing in restructuring and corporate litigation, and he combines his work in legal practice with his academic role as an assistant professor at Leiden University's law school. He holds cum laude master's degrees in Psychology and in Law (valedictorian) and earned his PhD on the psychology of financial and legal decision-making, completing an interdisciplinary study of how cognitive biases shape legal and commercial outcomes.

At Leiden University, he teaches the flagship course 'Psychology for Lawyers', supervises research on bias, risk perception and decision architecture, and publishes on cognitive bias, noise and moral intuitions in directors' liability, valuation disputes and open-norm adjudication. His current work proposes practical debiasing safeguards for courts and tribunals.

In practice, Niek acts in complex restructurings and liability cases, integrating behavioral insights to steer strategy and settlement. He also trains judges, arbitral institutions and law-firm teams across Europe to recognize and mitigate unconscious bias, and is launching the *Behavioral Science* in Law Academy, whose first online certificate course will equip legal professionals with a full behavioral toolkit – from diagnosing bias and designing choice architecture to evidence-based advocacy and negotiation – opening for enrolment later this year.



Jacomijn van Haersolte-van Hof

Leiden University / Fountain Court Chambers



Jacomijn (Jackie) van Haersolte-van Hof is an independent arbitrator and a professor of law at Leiden University. From 2014-2024 she was the Director General of the London Court of Arbitration.

She has continued to sit as arbitrator in commercial and investment arbitrations. Recent experience includes sitting as president in two ICSID annulment proceedings and as co-arbitrator and as presiding arbitrator in two international NAI arbitrations in a post M&A dispute.

As a Dutch lawyer, Jackie has extensive experience in other civil as well as common law legal systems. She has been involved in many cases involving States and state-owned entities and cases involving sales and general contract law, post-Merger & Acquisition disputes; energy law (including gas price review disputes); private international law; international law (investment law; immunity law); transport and commodities, shipbuilding, including off-shore; insurance.

As Director General of the LCIA, she guided the institution through challenges including Brexit, the COVID-19 pandemic and the rise of hostile international relations and associated issues, such as the impact of international sanctions on arbitration.

Jackie has also overseen the professionalisation and internationalisation of the LCIA; a huge growth of cases, turnover and staff; and strides in diversity (especially gender diversity).

He also regularly sits as an arbitrator.

Matthias is a seasoned advocate and appears regularly before courts and tribunals around the world. Over the last few years, he has first- or second-chaired more than 50 merits hearings, presenting opening and closing submissions on a wide range of subject matters and cross-examining dozens of fact and expert witnesses (including CEOs of multinational companies, auditors, forensic accountants, economists, commodity traders, physicists, engineers, mathematicians, law professors, and a former judge at the European Court of Justice).
